I am writing to confirm that the charity named above has been entered in the Central Register of Charities with effect from the date of this letter.

Enclosed is a print-out showing this charity's entry in the computerised Central Register. Please let me know if there are any inaccuracies in your entry. Charity trustees have a legal obligation, under section 3(7) of the Charities Act 1993, to keep us informed of any changes to this register entry or to their charity's trusts, and supply us with details of the changes. It is important for both donors and beneficiaries of charities that the details in the Central Register are kept up to date. To ensure that this is done on a regular basis, we will be writing to all registered charities each year, asking trustees to confirm or update their charity's registered details. You also have the option to use our online service to update your charity's details as changes occur. This service is available via our website [www.charitycommission.gov.uk](http://www.charitycommission.gov.uk), just follow "Click Online" to request a secure password for your charity.

We have recently made some changes to the way in which the Area of Operation is held on the Public Charity Register on our web-site. Because of this we may not have been able to record your Area of Operation in exactly the same way as you had described it on the application form. If the entry shown on the print-out is not as you would wish to see it, then you can change it. You can do this via the online facility that I described in the previous paragraph.


Please note that the Central Register of Charities is open to the public and the details in the print-out, other than the bank details, will be open to public inspection as will the charity's governing document, any documents effecting changes to the governing document and copies of its accounts (if available).

Finally, I would draw your attention to the fact that the entering of a charity name on the register does not give the charity which uses it any legal rights to that name. Also, whilst we will give advice about charity names which appear to be acceptable, we cannot guarantee that a name will continue to be suitable. We can direct a charity to change its name if it is the same as or similar to that of another charity or if the name is misleading or offensive.

We will not be responsible for any costs involved, incurred directly or indirectly by a charity where we have directed a change in the charity's name.

## The Tax Exemption

Income and capital gains arising in the course of charitable activities are normally covered by the tax exemption. But you should be aware that this might not apply where you have:

- significant levels of trading outside the primary purpose of the charity or
- expended funds for non-charitable purposes or
- made non-qualifying loans or investments.

## Your Tax Obligation

If you think there may be tax to pay you should let us know as soon as possible. Charities, like everyone else are subject to the usual tax obligation to notify chargeability.

## Tax Returns

Charities fall within the Self Assessment taxation legislation. There is a requirement to complete a Tax Return when requested to do so. The relevant forms can be obtained from the telephone order-line number (0845 300 6555 for Companies and 0845 9000 404 for Trusts) or by direct download from the website. Please note that accounts should only be submitted with a completed Tax Return.


